## **Records Retention Schedule (Academies)**

### Introduction

Please note that this schedule is based on the retention schedule contained within the Information Record Management Society (IRMS) Toolkit for schools, along with some customisations specific for Hertfordshire. The full document can be viewed at: <a href="https://irms.org.uk/page/AcademiesToolkit">https://irms.org.uk/page/AcademiesToolkit</a>. However, in order to download a customisable version, you need to be a member of the IRMS.

Under the Accountability and Transparency principles of the General Data Protection Regulation (GDPR) and the Data Protection Act 2018 (DPA 2018), academies are required to set and publish retention periods for the personal data they hold. In addition, under the Freedom of Information Act 2000, academies should maintain a Retention Schedule listing the series of records which the academy creates or maintains in the course of its business.

This Retention Schedule lays down the length of time for which the record may need to be retained and the action which should be taken when it is of no further administrative or legal use. Academies are expected to manage their current record keeping systems using a Retention Schedule and to take account of the different kinds of retention periods when creating new record keeping systems. This will ensure that information is not being stored and processed unnecessarily.

This Retention Schedule contains recommended retention periods for the different record series created and maintained by academies in the course of their business. It refers to series of records regardless of the media in/on which they are stored (e.g. paper/electronic/microfilm/photographic etc.). Where appropriate the Retention Schedule should be reviewed on a regular basis and amended to include any new record series created, and any obsolete record series removed.

Some of the retention periods are governed by statute, others are suggested guidelines based on best practice. Every effort has been made to ensure that these retention periods are compliant with the requirements of Data Protection and Freedom of Information legislation. However, please bear in mind that depending on which electronic systems are being used (e.g. for MIS), it may not always be technically possible to carry out some of the data deletion or minimisation in bulk, as required by the schedule. You may sometimes decide that some types of records need to be kept for longer or shorter periods than laid out in this document. If so, then the justification for this (e.g. for operational purposes or business needs) should be documented.

Staff should be aware that once a Freedom of Information request is received, or a legal hold imposed, then records disposal relating to the request or legal hold must be stopped. Records which may be required by the Independent Inquiry into Child Sexual Abuse (IICSA) should be treated as though they are subject to a legal hold.

Where there is a recommendation to archive the information this may be in an electronic format. There is no need to convert the information into a hard copy. Such records should be kept in separate electronic folder suitably marked as holding archival material.

Academies should also refer to the guidance given by their Local Authority Designated Officer (LADO) regarding retention of safeguarding records. Hertfordshire academies can find this information here: https://www.thegrid.org.uk/info/welfare/child\_protection/policy/local.shtml#pupilsafe
