### SNAPCHAT: MY AI

#### How do I turn off My AI on Snapchat?

My AI is a chatbot available on Snapchat that is automatically added to all Snapchatters' contact list. Only Snapchat+ subscribers can unpin or remove My AI from their contact list.

However, all users can take steps to remove My AI data regularly.

## To delete My AI data:

Step 1 – From your **profile**, tap the **gear icon** to open your **Settings**

Step 2 – On Android, scroll down to **Account Actions** and tap **Clear My AI data > Confirm**.

On Apple devices, scroll down to **Privacy Controls** and tap **Clear Data > Clear My AI data > Confirm**.
